



Biannual IBA Latin American Regional Forum Conference 17-19 March 2010 - Santiago, Chile

GROUP DISCOUNTS FOR CHILEAN DELEGATES

General Information

1. The discounts apply to **more than four** delegates with the same law firm or company in **Chile** registering for the conference;
2. The discounts are progressive, which means the more delegates a law firm or company sends, the bigger the discounts are;
3. All individual registrations must be sent at once with this summary sheet;
4. The discounts are open until **5 March**. Registrations submitted after that date will fall in the general fees category;
5. Fees include attendance to all working sessions, conference materials including any available speakers' papers submitted to the IBA, lunch, tea and coffee during breaks and invitation to cocktail on 17 March and to hosted reception on 18 March;
6. An individual registration is US\$670 for IBA members and US\$885 for non-members. **This package gives discounts over the IBA member rate even when the delegates are non-members;**
7. It is possible to also attend the Bar Leaders Conference on 17 March. In this case, **each delegate** should pay an extra US\$280;

- 5 registered delegates – **US\$3,280** (10% discount for the 5th registration)
